

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The World Health Organization has declared the novel Coronavirus (COVID-19) a worldwide pandemic. Due to its capacity to transmit from person-to-person through respiratory droplets, the government has set recommendations, guidelines, and some prohibitions which Showstars Dance Academy adheres to comply.

In consideration of my participation in services provided by Showstars Dance Academy, the undersigned acknowledge and agree to the following:

1. I am aware of the existence of the risk of physical appearance to the venue and participation in the services provided by Showstars Dance Academy that my child(ren) may be exposed to or infected by COVID-19 by attending Showstars Dance Academy and that such exposure or infection may result in personal injury, illness, permanent disability, and death.
2. My child(ren), as well as members of the household, have not experienced symptoms that of fever, fatigue, difficulty in breathing, or dry cough or exhibited any other symptoms relating to COVID-19 or any communicable disease within the last 14 days.
3. My child(ren) have not been, nor any member(s) of my household, diagnosed to be infected of COVID-19 virus within the last 30 days.

I understand that the teachers and staff at Showstars Dance Academy will make every effort to maintain social distancing, but there will be times when incidental contact and less than prescribed physical distancing will occur. I am aware that I may be asked screening questions upon my child's arrival and my child's temperature may be taken, and that students will be required to use hand sanitizer or wash their hands regularly during their time inside the facility as well as upon entering and exiting.

I acknowledge that safety procedures will change and evolve over time and I will follow any new standards required by public health officials and/or Showstars Dance Academy.

I understand and agree to all the new COVID-19 related rules and protocols administered by Showstars Dance Academy. I understand if my child is sick they will not come to class, and must have a doctor's note clearing them from COVID-19 before they can participate, or stay out of dance for at least 14 days symptom-free, whichever comes first. I understand my child will stay home if someone in my immediate household contracts the virus, and must have a doctor's note clearing them from COVID-19 before they can participate, or stay out of dance for at least 14 days symptom-free, whichever comes first. I understand I am willingly and voluntarily allowing my child to participate in an activity where they are around other people, thus increasing their risk of contraction. I understand the risk associated with allowing my child to participate in classes regarding COVID-19. However, while I also understand Showstars Dance Academy will do whatever it can to prevent the spread of the disease, Showstars Dance Academy cannot be held responsible should any child, parent or guardian contract COVID-19 while utilizing Showstars Dance Academy services and premises. I hereby release and discharge Showstars Dance Academy and any of its owners, directors, officers and employees from any liability whatsoever which may arise as a result of the student participating in events sponsored by Showstars Dance Academy.
